IREM was founded in 1933 and is an affiliate of the National Association of Realtors. Its core purpose is to advance the profession of real estate management while helping real estate managers prosper and add value to their companies and the properties they manage.

What is a Certified Property Manager (CPM®) ?

Receiving the (CPM®) Designation is the equivalent of receiving a Masters Degree in property management. The following is a highlight of the requirements.

- Education— through IREM courses, through other organizations, through academic achievement (several hundred hours)
- Experience— minimum of 36 months of qualifying real estate management experience
- Ethics— promise to uphold the IREM Code of Professional Ethics and pass the IREM ethics course
- Examination— show competency in all aspects of real estate management by passing a certification exam. In addition, demonstrate the practical application of all that has been learned on the job and in the classroom through a written management plan.
